Management Discussion of Fund Performance

October 21, 2011

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments during the past six months that have affected the Fund's performance and outlook since March 31, 2011, the Fund's most recent fiscal year-end. For information on the Fund's longer-term performance, please refer to the *Past Performance* section of the report. This report should be read in conjunction with the Annual Management Report of Fund Performance for the year ended March 31, 2011. In this report, "Mackenzie" refers to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

The Fund's NAV increased by 115.8% to \$134.0 million at September 30, 2011, from \$62.1 million at March 31, 2011. This change was composed primarily of \$5.0 million in net losses (after including interest income) from investment performance, after deducting fees and expenses, and \$76.9 million in net sales (which includes an inflow of \$61.1 million relating to asset allocation program and fund reorganization activities). The performance of the Fund's Series A securities is discussed below. The performance of all series is shown in the *Past Performance* section of the report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series.

Investors in registered accounts holding the Keystone Conservative Portfolio Fund and certain asset allocation programs managed by Mackenzie became investors in the Fund through a series of reorganizations that took place in May 2011.

Investment Performance

During the six-month period, the Fund's Series A securities returned -3.2% (after deducting fees and expenses paid by the series). This compares with a return of 0.8% for a blended index composed of a 65% weight in the DEX Universe Bond Index (returned 7.7%), a 26.25% weight in the MSCI World Index (returned -9.2%) and an 8.75% weight in the S&P/TSX Composite Index (returned -16.6%). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in the index without incurring fees, expenses and commissions, which are not reflected in the index returns.

The Fund underperformed the broad-based DEX Universe Bond Index because it is a balanced fund that currently has a 35% allocation to equities, which underperformed bonds over the period. Because of the Fund's composition, the blended index provides a more meaningful comparison. The Fund underperformed the blended index because both its fixed income and equity allocations underperformed their respective indices.

The Fund's target allocation of 65% to fixed income is achieved through its investment in Symmetry Registered Fixed Income Fund. This fund underperformed the DEX Universe Bond Index primarily due to its exposure to high-yield bonds and income-paying equities, which experienced negative returns. Overweight exposure to corporate bonds, which underperformed government bonds, also detracted from relative performance.

The Fund's target allocation of 35% to equities is achieved through its investment in Symmetry Equity Class, which underperformed the MSCI World Index. This underperformance resulted from its exposure to Canadian equities and weak returns from its holdings in small-cap and recovery stocks. This fund is diversified by investment style, and over the period portfolio managers employing a value investment style underperformed those focused on high-quality growth stocks.

Fees and Expenses

The annualized management expense ratio ("MER") for Series A of 2.40% during the six-month period ended September 30, 2011, was slightly higher than the MER of 2.38% for the year ended March 31, 2011. The MERs (before and after waivers or absorptions) for each series are presented in the *Financial Highlights* section of this report.

The Governments of Ontario and British Columbia harmonized their provincial sales taxes with the federal goods and services tax effective July 1, 2010. This increases the amount of taxes paid by the Fund on its expenses, including but not limited to management and administration fees during the period.

The MER for each series consists of the management fee, administration fee and other fund costs, as applicable to that series. Other fund costs include taxes (including but not limited to GST/HST and income tax), interest and borrowing costs, fees and expenses of the Mackenzie Funds' Independent Review Committee ("IRC"), any fees related to external services that were not commonly charged in the Canadian mutual fund industry as at June 15, 2007, and the costs of complying with any new regulatory requirements after June 15, 2007.



Recent Developments

Recent events and heightened market volatility have amply demonstrated the benefits of diversification in limiting overall portfolio risk. While equities have experienced extreme ups and downs over the last few years, fixed income assets have been more stable, dampening overall portfolio volatility. The portfolio managers believe that equities will outperform bonds over the longer term. Investors are well advised, however, to maintain a balanced allocation to both fixed income and equities to meet longer-term return objectives while reducing risk.

Future Accounting Standards

As previously confirmed by the Canadian Accounting Standards Board (“AcSB”), most Canadian publicly accountable entities adopted all International Financial Reporting Standards (“IFRS”), as published by the International Accounting Standards Board (“IASB”), on January 1, 2011. However, the AcSB has allowed most investment funds to defer adoption of IFRS until fiscal years beginning on or after January 1, 2013. Accordingly, the Fund will adopt IFRS for its fiscal period beginning April 1, 2013, and will issue its initial financial statements in accordance with IFRS, including comparative information, for the interim period ending September 30, 2013.

Mackenzie has identified the key differences between IFRS and Canadian generally accepted accounting principles (“GAAP”) that are expected to affect the Fund, and has developed an IFRS changeover plan, including a formal project governance structure, that addresses key elements of the conversion to IFRS. Elements of the plan include evaluating the impacts of the changeover on all business activities, accounting policies, information technology and data systems, internal controls over financial reporting, and disclosure controls and procedures. As the Fund’s changeover plans are implemented, requirements for financial reporting resources and training are being modified appropriately.

Based on Mackenzie’s current evaluation of the differences between GAAP and IFRS, the adoption of IFRS is not expected to have a significant impact on the calculation of NAV per security. IFRS is expected to affect the overall presentation of financial statements and result in additional disclosure in the accompanying notes. Mackenzie continues to monitor changes to IFRS proposed by the IASB and relevant amendments by the AcSB, and the current assessment and IFRS changeover plans may change if new standards are issued or interpretations of existing standards are revised.

Related Party Transactions

The following arrangements result in fees paid by the Fund to Mackenzie or to companies affiliated with the Fund.

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Mackenzie at the annual rates specified under *Fund Formation and Series Information* in this report and as more fully described in the Prospectus. In return for the administration fees, Mackenzie pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not otherwise included in management fees. See also *Management Fees*.

Other Related Party Transactions

During the period, Mackenzie relied on the positive recommendation of the IRC to permit the Fund to purchase and sell securities of other funds managed by Mackenzie. The IRC issued the recommendation on the basis that the transactions in fund securities would be made in compliance with Mackenzie’s policies.

Investment funds managed by Mackenzie may invest in certain securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. Series S securities are also issued on a prospectus-exempt basis to segregated funds offered by London Life Insurance Company, The Great-West Life Assurance Company and The Canada Life Assurance Company (collectively, the “Related Insurance Companies”), all of which are companies affiliated with Mackenzie. At September 30, 2011, there were no Series S securities issued.

At September 30, 2011, Mackenzie had an investment of \$1,028 in the Fund (0.0% of the Fund’s NAV).

Mackenzie relied on a recommendation issued by the IRC in proceeding with transferring both registered investors in certain asset allocation programs managed by Mackenzie and registered investors in Keystone Conservative Portfolio Fund into the Fund in May 2011.

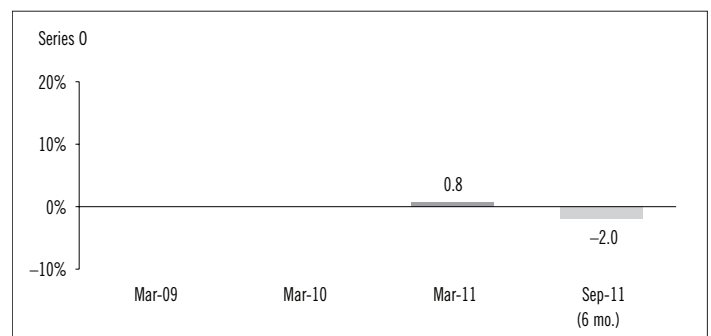
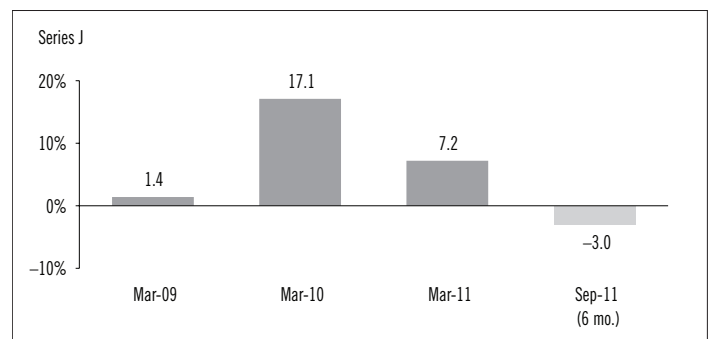

- (5) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund. The portfolio turnover rate is not provided when the Fund is less than one year old. The value of any trades to realign the Fund's portfolio after a fund merger, if any, is excluded from the portfolio turnover rate.

Management Fees

The management fee for each applicable series is calculated daily as a percentage of its NAV. The Fund's management fees were used by Mackenzie to pay for the costs of managing the investment portfolios of the underlying funds, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, as well as for providing other services. Mackenzie also used the management fees to fund sales commissions, trailing commissions and any other compensation (collectively "distribution-related payments") to registered dealers and brokers whose clients invest in the Fund.

The following dealers affiliated with Mackenzie may be entitled to distribution-related payments from Mackenzie on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., M.R.S. Securities Services Inc., IPC Investment Corporation, Investors Group Financial Services Inc., M.R.S. Inc., M.R.S. Correspondent Corporation and Partners in Planning Financial Services Ltd. On September 2, 2011, Mackenzie entered into a transaction which, subject to regulatory approvals, is expected to result in M.R.S. Inc., M.R.S. Securities Services Inc. and M.R.S. Correspondent Corporation no longer being subsidiaries of Mackenzie.

Mackenzie used approximately 40% of the total management fee revenues received from all Mackenzie funds during the period to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 50% of the management fees paid by all applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series. The higher proportion of distribution-related payments is primarily attributable to sales commissions related to gross sales of redemption charge securities of the Fund.



Fund Formation and Series Information

The Fund may have undergone a number of changes, such as a reorganization or a change in manager, mandate or name. A history of the major changes affecting the Fund in the last 10 years can be found in the Fund's Annual Information Form.

Date of Formation November 19, 2008

The Fund may issue an unlimited number of securities of each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*.

Series A securities are offered to retail investors investing a minimum of \$10,000.

Series AR securities are offered to retail investors in a Registered Disability Savings Plan offered by Mackenzie.

Series B securities were created specifically for the purpose of implementing mergers affecting the Fund and are not available for sale.

Series E securities are offered to investors who are enrolled in a dealer-sponsored fee-for-service or wrap program, who are subject to an asset-based fee rather than commissions on each transaction and who invest a minimum of \$250,000.

Series F securities are offered to investors who are enrolled in a dealer-sponsored fee-for-service or wrap program, who are subject to an asset-based fee rather than commissions on each transaction and who invest at least \$10,000; they are also available to employees of Mackenzie and its subsidiaries and directors of Mackenzie.

Series G securities are offered to retail investors investing a minimum of \$10,000 who are members of a group RRSP, DPSP, TFSA, or pension plan.

Series I securities are no longer available for sale.

Series J securities are offered to investors investing a minimum of \$250,000.

Series O securities are offered to investors investing a minimum of \$500,000 who have entered into a Series O account agreement with Mackenzie, and also available to certain qualifying employees of Mackenzie and its subsidiaries.

Series S securities are offered to the Related Insurance Companies and certain other mutual funds, but may be sold to other investors as determined by Mackenzie.

An investor in the Fund may choose among different purchase options that are available under each series. These purchase options are a sales charge purchase option, a redemption charge purchase option and a low-load purchase option. The charges under the sales charge purchase option are negotiated by investors with their dealers. The charges under the redemption charge and low-load purchase options are paid to Mackenzie if an investor redeems securities of the Fund during specific periods. Not all purchase options are available under each series of the Fund, and the charges for each purchase option may vary among the different series. For further details on these purchase options, please refer to the Fund's Simplified Prospectus.
